

Yellow Dog Van Adventures Waiver

As a Participant, I understand and acknowledge that all of the activities I will be participating in during the Event, for example, off-roading, camping, and hiking (“Activities”) involve known and unknown risks, dangers and conditions which can result in physical injury, paralysis, illness, disease, or even death to myself, as well as damage to my personal property, including any vehicle (collectively the “Risks”). I further understand and acknowledge that such Risks cannot be fully eliminated without negatively impacting the goals and overall experience of the Activities I have chosen to participate in. By way of example these Risks may include, but are not limited to, the following:

- Conditions of and the use of roads (public and private), trails, and general terrain
- Use and operation of my vehicle on roads, trails, and general terrain
- Wilderness camping
- Use or operation of equipment or tools supplied by the Yellow Dog Van Adventures LLC or other persons or entities
- Weather conditions
- Limitations on the prompt delivery of advanced medical services to deal with medical emergencies
- Limitations on the ability to immediately evacuate a Participant due to medical emergencies
- Conditions caused by the consumption of fluids, food, and medications
- Actions and omissions, including acts of negligence, by Yellow Dog Van Adventures LLC, its employees, agents, owners, and officers as well as by third parties contracting with Yellow Dog Van Adventures LLC
- Encounters with wild animals and exposure to plants and possible toxic substances
- My own physical condition, limitations, and restrictions
- My own actions or omissions, including acts of negligence.

During the Yellow Dog Van Adventures LLC event, I acknowledge that I will be driving on technical terrain, which may include but is not limited to, steep and uneven surfaces, loose rocky surfaces, large rocks and boulders, trees and tree branches, exposure to vertical terrain, unmaintained roads and tracks, and river crossings. Additionally, the route may be a high and low-altitude route with the possibility of extremely changeable weather conditions and a very high UV exposure index. I further acknowledge that I will listen to and follow the Yellow Dog Van Adventure LLC guide’s instructions at all times when driving during the event.

I understand and acknowledge that there may be other Risks in addition to those listed above and that the above list is not intended to be exhaustive.

In consideration of the opportunity to participate in the Activities, for which I have contracted for, I hereby (i) expressly accept all such Risks, without limitation; (ii) agree to voluntarily participate in the Activities despite these Risks, whether known or unknown; and (iii) release and waive all claims and actions, including claims of negligence, I may have against Yellow Dog Van Adventures LLC, its employees, agents, owners, and officers, including subcontractors and volunteers for any and all injuries or conditions of any type, including death, that I may suffer, as well as damage to my personal property as a result of my participation in the Activities.

Yellow Dog Van Adventures Waiver

If Yellow Dog Van Adventures LLC is forced to defend or enforce the provisions of this Agreement against me and is successful in such action, I hereby agree to pay and reimburse all costs, expenses, and disbursements, including reasonable attorney fees, incurred by Yellow Dog Van Adventures in the defense or enforcement of such action.

I hereby certify that (i) I am physically fit to participate in the Activities without limitation and that I have fully disclosed to Yellow Dog Van Adventures LLC any and all information regarding any medical condition I have or may have which could limit my participation; (ii) I will not consume any alcoholic beverage or take any drug (unless prescribed by a medical doctor) while participating in the Activities so long as such prescribed drug will not impair my judgment or limit my ability to operate a motor vehicle or equipment; and (iii) I have in place adequate and fully paid for, liability insurance coverage to cover injury, death and property damage to myself, and other third parties resulting from the operation of my vehicle at all times during the Activities.

I hereby give Yellow Dog Van Adventures LLC permission to use any images or video taken during this trip for promotion on its website, social media channels, and/or any other promotional venue with or without identification of subjects and with no expectation of payment for the use of these images or videos.

I hereby understand, acknowledge and agree that in any action brought by me against Yellow Dog Van Adventures LLC for any loss to my person or property, it may be determined by a court of law that by signing this Agreement I have waived any right I may have had to sue Yellow Dog Van Adventures LLC for any such loss resulting from my voluntarily participation in the Activities.
